- Multiple policies with American Modern – 5%

- No claim in past 3 years – 28%

Options offer customers added protection

- Water damage is included at 100% Coverage A (with \$3,500 mold limit) – owner, rental or seasonal occupancy. The percentage can be reduced to 10, 25 or 50% as one way to meet a customer's budget number.
- Partial losses to a dwelling are by default covered to the actual cash value, but coverage can be increased to full repair cost (insure home to market value excluding land value) or to replacement or extended replacement cost (insure home to replacement cost excluding land value).
- The Enhanced Coverage endorsement increases the limits in supplemental coverage, such as personal property.
